Razionale



1. Many interpretations of the phenomenon of addiction and its pathological manifestations are often based on **concepts and approaches which do not take into account scientific evidences, especially from neuroscience.**




2. Researchers and their scientific findings and working methods are **poorly connected and shared**, slowing down scientific discoveries and reducing global knowledge on the topic.



3. **Poor connection between researchers** conducting ground-breaking and advanced research in the field of the neuroscience of addiction **and healthcare professionals and education and rehabilitation professionals.**

1. Promoting scientific research and the sharing of information, scientific protocols, methods, good practices in the field of neuroscience of addiction




2. Creating a global community promoting a new approach to the phenomenon of drug use and addiction which has neuroscience as its starting point




3. Improving national and international systems engaged in research and management of addiction via the promotion of mutual support generated by the collaboration of professionals working in the addiction field


